Please have a 2017-2018 FAFSA on file with the UNC Asheville Office of Financial Aid by June 1, 2018. Summer session aid is contingent upon your eligibility for the Pell Grant and remaining eligibility from Federal Stafford Loans. Complete this form and submit to Office of Financial. Notification of your Summer Awards will be sent via your UNC Asheville Email Address. Due to the large volume of applicants we will not be able to determine your award (estimate or otherwise) until after May 11th, 2018.

Federal Stafford Loan Eligibility

Your eligibility for a Federal Stafford Loan for a summer session is contingent upon the federal loan limits based on credit hour completion and your dependency as determined by FAFSA. At UNC Asheville, summer session is still considered part of the 2017-2018 academic year. Therefore, you cannot receive more than the federal loan limits denoted below for the fall, spring and summer cumulatively.

Federal Pell Grant Eligibility

- You must have a Pell Grant eligible Expected Family Contribution (as determined by the FAFSA), enrolled as a degree-seeking student in your first undergraduate degree.
- Students may be eligible to receive Pell Grant funding for the summer term if he/she was not full time during the fall and spring terms.
- Students may be eligible to receive Pell Grant funding for the summer term if he/she is taking at least six credit hour for the summer term and has a Pell Grant eligible Expected Family Contribution (as determined by the FAFSA), enrolled as a degree-seeking student in your first undergraduate degree.
- Student cannot receive more than their full time scheduled awards.

Requirements to Receive Summer Financial Aid:

Please Note that your entire Financial Aid Award is subject to change based on Federal and State Funding.

- You must be enrolled in at least 6 credit hours.
- You must be registered for all of your summer session classes by the beginning of the first summer session or you financial aid will be cancelled.**
- If you plan to attend both sessions, you must register for both at the beginning of the first session. Withdrawal from hours, after the financial aid has been credited to our account, will result in a reduction of aid for any subsequent sessions and charges on your account. Undergraduate students, who register for 6 hours (half-time) and subsequently drop below half-time, will have all financial aid cancelled, and will owe the full amount of charges to UNC Asheville.
- You must be maintaining satisfactory academic progress for financial aid as noted in the UNC Asheville Office of Financial Aid Handbook. (If you receive notification of your summer award prior to the spring satisfactory academic progress evaluation and you have not maintained satisfactory academic progress, your award will be cancelled.)
- You must have a 2017-2018 FAFSA on file by June 1, 2018.** If you do not meet this deadline, you may be required to pay your tuition, fees and any other charges at the time of registration.
- Visiting and non-degree seeking students are not eligible for financial aid.
